

Exhibition Regulations

Insurance

The organizers are responsible for the general security of the entire venue by general insurance public liability for damnification of health and survival and/or property damage of the third men, but will not undertake any financial or legal responsibility for any type of risk concerning or affecting the exhibitors, their personal belongings and exhibits.

Photographing, Video Shooting and Sound Recording

No photo taking, video shooting and sound recording will be allowed in the exhibition hall unless approved by the organizers in advance.

Delivery of Exhibits

Exhibits should not be sent to venue any units until the stand is ready by our contractor. Exhibitors should arrange for a representative to be at the stand to receive goods as the organizers will not accept or sign for any goods, exhibits or other materials on behalf of any exhibitors. The official arrival of exhibitors from 09.00 to 18.00 17.06.12

Removal of Exhibits

Removal of exhibits may commence only after 4 p.m. on June 21, 2012. Exhibitors, their agents or contractors are responsible for the complete removal from the Fair Grounds and outside areas of all goods and materials used by them, together with all rubbish. The organizers are not liable for any loss or damage of the exhibits or stand materials left behind at the exhibition venue. All such materials and constructions should be evacuated; otherwise the organizer is not liable for their safety. All materials and constructions of exhibitor are to be removed before 8 p.m. on June 22, 2012.

Intellectual Property Rights

The organizers shall have the right to require exhibitors to remove exhibits which are alleged of violating intellectual property rights. All exhibitors found guilty of infringement of intellectual property rights shall be banned from participating in all trade fairs organized by the organizer.

Exhibition Space Cleaning

The Organizer is responsible for the cleaning of the Exhibition Centre, the halls and the aisles. Cleaning of each stand is carried out by stand personal. Each exhibitor is responsible for the removal of the wastes from the stand.
